Water & Sewer Service Information

The ordinances upon which this information is based may be read in full at City Hall.

A **\$100.00 deposit is required** to initiate water and sewer service and is due at the time of application. **The deposit may be returned after two (2) years of consecutive non-delinquencies.** In the event you move out of town before that time, the deposit will be returned once your final bill payment has cleared.

The owner of each property supplied with service shall be held responsible for the payment of all bills for services furnished to that property

The full cost of the meter shall be paid to the City by the property owner or customer prior to the installation of any such meter by the City, or, at the sole option of the City, the property owner or customer may be required to purchase and install such meter in accordance with requirements established by the City.

Water rates are as follows based on cubic feet used during the 2 month period:

Cubic Feet/Gallons Used Per Bimonthly Billing Period	Rate
First 267.4 cubic feet (2000 gallons)	\$36.00 (minimum bill)
All over 267.4 cubic feet (2000 gallons)	\$4.00 per 133.7 cubic feet (1000 gallons)

Every customer furnished water through a meter shall be charged and pay a minimum, or ready to serve, charge of \$36.00 per billing period for each meter, for which the consumer shall be allowed 2000 gallons of water.

Sewer rates are as follows and are based on water usage:

The minimum sanitary utility charge rate or rental shall be \$45.00 per two-month billing cycle. Use of less than 2900 cubic feet of water per billing period will be charged \$45.00 per two-month billing cycle. Over 2900 will be charged at 70% of the total charge of the water bill.

Meters are read every other month. The **west side** of town will be read in **January, March, May, July, September and November**. The **east side** of town will be read in **February, April, June, August, October and December**. Payments are due in the office by 4:30 p.m. the 10th day of the month following the reading. When that day falls on the weekend or a legal holiday, the payment is due the following business day. **Please return the stub section of the bill with your payment. A DROP BOX IS ALSO AVAILABLE.**

A 10% penalty shall be added to the outstanding amount for bills unpaid by the due date.

Delinquent letters shall be sent to those who have not paid their bills by the 20th day of the month. This will include the new balance.

Should the bill remain unpaid as of the last day of the month, water service is to be disconnected and not restored until the bill has been paid in full and a \$100.00 re-connect fee has been paid.
