May 8<sup>th</sup> was discussed with city issued pickup being at Jeff's residence for 3 hours in the morning and he was checked into work as observed by Wes White. Jeff said that he had went to a funeral but did not call to let anyone know that he was there and did not punch out so was paid by city. This was not acceptable to not have permission from either the mayor or a council member prior.

May 12<sup>th</sup> pickup was home at 11:20 and Jeff was still punched in then left at noon to take the afternoon off.

After much discussion regarding these and other issues from an October 2016 meeting a Motion was made by Lamberson and seconded by Hudson to terminate Jeff Bittner's employment from the city effective immediately due to misconduct.
