- J. Jack Pope discussed the bids for the wastewater treatment construction. All the bids were higher than anticipated. The lowest bid was from Woodruff Construction, LLC of Tiffin, Iowa in the amount of \$1,853,000. The Engineer's Opinion of the Probable Costs for the work was \$1,483,100.00. Jack has made an outreach to SRF and the DNR in regards to the increase in the total. We are short about \$250,000 of the Ioan we are asking for. Engineering at this time has come in under budget Jack stated. There were 45 plan sets taken out and only 3 bids submitted to be considered by the award date. Discussion was held on reletting bids and that would make us not necessarily meeting the schedule for completion and also Jack did not think they would come in any lower. We will need to be in touch with Travis Squires and the bonding agent to finalize funding.
