Discussion held in appointing a new mayor Both Leslie Var

B. Discussion held in appointing a new mayor. Both Leslie VanWyk and Keri Lamberson had put in their names to be considered for appointment.

**Leslie VanWyk** spoke first and stated that she moved here in 2008 and would like to be more involved with the community. She would like to be a voice to be sure that our town is not overlooked. She was a manager at Verizon working with the public and also from a public service family so she has served doing many public service activities.

**Keri Lamberson** then addressed the council. She has been on the city council for 7 years and have been associated with New Sharon for approximately 17 years. She would like to continue trying to promote our town to bring in more businesses and people. She stated we have a lot to offer in our town. She has enjoyed being on the council and working to help the city have better water and sewer systems. She is willing to explain to the public why the council made the decisions they did. Keri is a manager of a call center at Musco and handles the complaint side of things. Keri would like to continue the progress the council and city has made over the last 8 years.

Dustin then asked what area would you like to see the city work on or improve in the next year? **Leslie VanWyk** was asked this question first and her answer was to repair the side streets and sidewalks and build on the infrastructure that is already in place. **Keri Lamberson** then was asked the same question and her response was to continue working on the city streets, and she said that we are purchasing better equipment for our employees to work on them. She would also like to help local businesses to improve so people have access to park and to shop.

In closing statements **Keri Lamberson** said that she would like to implement having office hours one day a week for a couple of hours so that the public could feel free to come in and meet with her with any questions or concerns they might have. **Leslie VanWyk** said that she would be readily available to the public. She takes pride in whatever task she takes on to do it and do it well.

She will have more details at a later date for this.
