- E. Discussion held in response to the employee evaluations. Tom German and Keri Lamberson performed the evaluations with Lisa, Clay and Doug. Tom German and Larry Applegate performed the evaluation with Kevin Lamberson. It was discussed to give a 3% pay increase for the FY2020 and then look into some other insurance options possibly instead of an increase in the coming year. Lisa and Keri will check with some companies in regards to health, family health and other options for employees.

The loan will be used prior to the grant and the city will pay the contractors invoices out of the loan. Also the grant money will need to be a 50% matching funds with the city paying the invoices.

- J. Terry Anderson was here to discuss the building at 105 S. Main. He said the main problem with an individual owning this property is that the state will not allow it since the sewer line from 103 S. Main runs through the basement of this building. Also about 30% of the roof is caved in and 30% of the floor joists. There is a crawl space under part of the building and a basement under the other part. He figures it would take at least \$66,000 to make the building safe. If we are going to keep the building we would need to write up work descriptions and put it for bids. Per the state fire marshall there are certain things that must be done to secure the building for fire. In regards to concern of the walls caving in to remove the building Terry said that you could put brick pillars which would be around \$10,000-\$12,000 to stabilize the other buildings. The council will discuss this and look into the best option for the city.
- K. Jack Pope gave an update on the wastewater project and the NE sewer project. The Wastewater project at the lagoon is on hold through the winter. The NE sewer project is at the stage to obtain the land to build the lift station. The area being looked at is property on N. Elm and E. Water Street. The lift station will need approximate .08 of an acre of land. Once the property has been obtained we can go ahead and put this out for construction bids. The projects can both be ongoing at the same time since this will be different construction areas. The cost of the project is approximately \$360,000 which was put into out SRF loan for the wastewater project.
