L. City Attorney Dustin Hite discussed some of the revisions to the code of Ordinances and answered questions from the city council. Chapter 1:14 Simple Misdemeanor we need to remove the jail time. Dustin will write up some language in regards to 52:06 regarding weed control; Sewer tapping we will increase fees for commercial and Dustin will write up new ordinance language in regards to this. He will also send us some new examples of sewer

tapping applications. The building permit ordinance was discussed in great length. Discussion was held rather we wanted to include an concrete such as driveway, patio or just begin with a specific size patio, also it was discussed to have an inspector that would look at the building permits prior to the time for approval to determine if the owners have complied with all of the setbacks. They would then inspect the areas after they are built to be sure they are also within the limits they stated on the permit. At this time Tom German suggested that we just leave the building permit ordinance as it is now stated and look possibly changing our resolution regarding having a public hearing and the time frame that we would need the applications turned in so that we could have them inspected. This will be on an agenda at a later date. Attorney Hite will send us the changes he suggested and we will then forward those to lowa Codification to be included in this revision.

It was asked about insurance on this equipment and if the he or the secretary for the Association would be calling McGriff insurance to add this the city insurance since the Association does not have insurance. Josh stated since he is busy he would like for Lisa to handle that for them. He will forward the information to her as soon as he gets it and she can work with Amy at McGriff insurance.
