- 7. Swearing in of Fire Chief- Mayor Long swore in Josh Crouse as fire chief.
- 8. Resolutions and Motions:
- **A.** Discussion was held in regards to raising fire township levy to 06075 per \$1000 assessed value.

Josh Crouse stated that with the cost of the EMA/911 levy that was put on the city in the amount of \$53,000 the fire department would be responsible for ½ of that and even with raising our levy to the max that only amounts to an additional \$13.490.90 which does not cover that. Also, the cost of fuel, and insurance has gone up so the expenses are higher. Dustin Hite stated that the cities of What Cheer, Pella, and Oskaloosa are at the max right now so a portion of these townships are already paying the max levy. If we are thinking of doing this now is the time since everyone is working on their budgets and we need to give a 60 day notice. In the past the trustees have wanted a meeting to discuss this so we need to be prepared that they may request this again. We are not required to do a public hearing for these 28E agreements. Council said they hate to raise taxes but also, we would not need as much equipment or have as much expense if we did not service the townships. After much discussion it was decided to bring this to a vote.

B. Motion made by Stout and seconded by Wyatt to approve raising the fire levy to .6075 from .55 per \$1000.00 evaluation.

- **C.** Discussion was held in regards to purchasing the Physical Asset Management from G-works in the amount of \$15,900.00. We can use the ARP money towards this since it allows for the mapping and tracking of important infrastructure improvements and roads updates quickly and effectively all while practicing social distancing and safe work practices. This will be on the web and able to access from a phone instead of coming into the office and looking at maps. Will save time and be more accurate. We can use this for the sewer lines, manholes and both of our cemeteries. After the first year we will not owe the \$3500 for the implementation and Lisa will check to see if we have to extend our contract after the three years for the enhanced consulting fee.
