This year was one of the first years that there was no dividend given through IAMU and that was due to the amount spent on the derecho. EMC has very good cybersecurity which is what we had the last two years. The cities work comp mod went down from 1.31 to .91 which Amy congratulated the city on. If we increase our deductible from \$2500 commercial property deductible to \$5000 deductible that saves us \$1937 this year.
