- E. Discussion with Zack VanderBeek regarding light poles at 308 S. Park and also discussion on purchasing an easement. Zack stated that there are 2 light poles on his property that feed the street lights on S Park. He presented a letter from Mid American Energy in regards to the cost of moving those poles and reconnecting the street lights. The amount due is \$4679.50 and since they are for the city street lights Zack feels that it is the cities responsibility to pay this.
