C. Discussion regarding cats running loose. Nicole with animal control Stephens Animal Shelter and Cheryl Holub animal rescue were here to discuss the cat problem in one of the areas of town. Cheryl said that she has a trap, neuter and release program. She can either bring the cats back to the property here or she does have a barn cat program and a relocation program. She does this at no cost as a liaison to help the shelters. Nicole said Stephen's shelter is at or over capacity for both dogs and cats at this time. Stephens only euthanizes for medical need, danger for adults. Cheryl stated that cats will travel for love and food. Cheryl said that we could look at relocation of cats if there are a number of them in one hot spot in town. She would like to talk to some of the homeowners and take a count of how many cats, ages, health condition. Eric Jones said he had 15 fixed and vaccinated due to the shelter full and not able to take them. He said he spent about 1500.00 on getting this done. Scott Williams said that he does not have any pets but he has had cat and dog feces in his yard. Cheryl said that in regards to the Edmundson cats in Oskaloosa they have moved these cats to a more remote location, only feed them twice a day for 30 minutes and then remove the food so that it does not attract wildlife or other stray cats. This has worked there. Lisa asked Nicole about the contract with Stephen's and she stated that even if contracted if they are full, they may not be able to pick up the animals unless dangerous.
